Where do I start if I don't have health insurance?

If you are uninsured, you may be able to locate a provider at a local health center or clinic, or even a nearby university or teaching hospital where services can be provided based on your income.

Prescription drug insurance is different from medical health insurance, but sometimes is included in your coverage. The cost of your medication will depend on how your prescription benefits are structured. Everybody can benefit from knowing more about how to pay for their prescriptions:
